



CAT HAUS BOARDING WAIVER

I, _____, the legal guardian of _____ (hereinafter “my cat(s)”), hereby agree to the following terms and conditions of my cats participation in the activities at Queen West Animal Hospital (herein referred to as ‘QWAH’) Animal Haus Boarding Facility.

Health & Wellbeing

I hereby certify that my cat(s) is /are in good health and has/have not been ill with any communicable condition in the last 14days.

1. I understand that I am solely responsible for any harm caused by my cat(s) while my cat(s) is/are attending QWAH Animal Haus Boarding Facility.
2. I understand that despite the best efforts of the employees at QWAH Animal Haus Boarding Facility, accidents can occur. Pursuant to this agreement and in consideration of the due diligence exercised by the staff, I hold QWAH Animal Haus Boarding Facility harmless for any liability with respect to loss or damage resulting from disease, theft, fire, death, escape, or injury to my cat(s).
3. Standard precautions will be used against injury, escape or death of this cat. QWAH Animal Haus Boarding Facility will not be held responsible for injuries that occur, provided standard care and precautions have been followed as determined at the sole discretion of QWAH Animal Haus Boarding Facility.
4. I agree that QWAH Animal Haus Boarding Facility may seek veterinary care for my cat(s) if such care is deemed reasonably necessary for the welfare of my cat(s). QWAH Animal Haus Boarding Facility agrees that they will make a reasonable effort to contact the Primary & Secondary Contacts or Emergency contact(s) to arrange transport to the primary treating veterinarian, unless the cat is in a state of medical emergency or critical condition. In this case, I understand my cat will be seen by any Doctor of Veterinary Medicine at Queen West Animal Hospital located on the first floor of the facility during regular business hours. QWAH Animal Haus Boarding Facility agrees that they will make a reasonable effort to contact the Primary & Secondary Contacts or Emergency contact(s) to arrange for transport to a Veterinary Emergency Facility when Queen West Animal Hospital is closed.
5. I hereby certify that my cat(s) will remain current in all vaccinations as set forth by QWAH Animal Haus Boarding Facility requirements. I understand that I must provide veterinary proof of such vaccination both before my cat’s first visit at the facility, and periodically as required when vaccinations are updated.
6. I hereby agree to maintain my cat(s) scheduled flea preventative as appropriate, or when requested by QWAH Animal Haus Boarding Facility. I will be responsible for any costs incurred for any such treatment if required.
