- 2. I understand that I am solely responsible for any harm caused by my cat(s) while my cat(s) is/are attending QWAH Animal Haus Boarding Facility.
- 3. I understand that despite the best efforts of the employees at QWAH Animal Haus Boarding Facility, accidents can occur. Pursuant to this agreement and in consideration of the due diligence exercised by the staff, I hold QWAH Animal Haus Boarding Facility harmless for any liability with respect to loss or damage resulting from disease, theft, fire, death, escape, or injury to my cat(s).
- 4. Standard precautions will be used against injury, escape or death. QWAH Animal Haus Boarding Facility will not be held responsible for injuries that occur, provided standard care and precautions have been followed as determined at the sole discretion of QWAH Animal Haus Boarding Facility.
- 5. I agree and understand that cats can sometimes receive minor cuts and scratches while playing in a group setting and any problems that develop with my cat(s) will be treated as deemed best by the staff of QWAH's Animal Haus, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
- 6. I agree that QWAH's Animal Haus may seek veterinary care for my cat(s) if such care is deemed reasonably necessary for the welfare of my cat(s). QWAH Animal Haus Boarding Facility agrees that they will make a reasonable effort to contact the Primary & Secondary Contacts or Emergency contact(s) to arrange transport to the primary treating veterinarian, unless the cat is in a state of medical emergency or critical condition. In this case, I understand my cat will be seen by any Doctor of Veterinary Medicine at Queen West Animal Hospital located on the first floor of the facility, during regular business hours. QWAH's Animal Haus agrees that they will make a reasonable effort to contact the Primary

& Secondary Contacts or Emergency contact(s) to arrange for transport to a Veterinary Emergency Facility when Queen West Animal Hospital is closed.

- 6. I hereby certify that my cat(s) will remain current in all vaccinations as set forth by Animal Haus requirements. I understand that I must provide veterinary proof of such vaccination both before my cat's first visit at the facility, and periodically as required when vaccinations are updated.
- 7. I hereby agree to maintain my cat(s) scheduled tick and flea preventative as appropriate, or when requested by Animal Haus Facility. I will be responsible for any costs incurred for any such treatment if required.

- 5. I understand that group play is not for cats that have temperament problems such as aggression or extreme shyness with either humans and/or cats.

If your cat is found to exhibit any behavior that is deemed unsuitable by the staff of QWAH's Animal Haus, they will be removed from the playgroup and you will receive a call with an explanation as to why your cat was removed. QWAH's Animal Haus has a zero tolerance policy, and must protect the safety of other cats and staff members.

I have read, understood and agreed to all provisions of this agreement. I understand that allowing my cat(s) to participate in activities at QWAH's Animal Haus are not without risk to my cat, and I accept and agree to be fully responsible for the consequences of assuming such risks. I hereby release QWAH's Animal Haus and their staff, agents, officers, members, and guests from any liability for injuries, illness or damage results from the actions of my cat(s), any other cat, or any human in the facility starting with the date indicated below and thereafter.
